### Speakers

**The Business Meeting was called to order at 8:35 PM**

### Minutes

W9NPI gave the brief summary of the Holiday Party Meeting, and read a thank-you letter received from the Salvation Army regarding our gifts to them. K8UP advised that Jimi's Restaurant provided the Greek Salad that we enjoyed, and requested that an Appreciation Letter be sent to them. ### Treasurer's Report

Treasurer K8UP presented his Report. Motion to Approve Treasurer's Report: W8WRB. Second: AA8UU; *Passed Unanimously*

### Swap Report by WD8S

Over the past week, many calls for tables have come in, but no reservations will be made without payment. Volunteers will meet at Jimi's Restaurant on the Saturday before the swap to set up and arrange the tables. About 50 will be rented, and the total number of tables for swap use will be 150.

N8FE will email assignments to members who have volunteered to work the doors, etc. at the swap. Duties are scheduled in Two-Hour increments.

The Food Booth will be in the Commons area, run by the Hazel Park Boosters' Club at no cost to HPARC. Prior to this, HPARC paid upwards of \$800 for school employees to run a food concession, with no profit to the club.

### Old Business

KE8UM mentioned that we still needed Net Control Operators for the HPARC Sunday Net, and a sign-up sheet was on the front table.

### Training

K8UP reported that of the nine amateurs who attended the Southfield EOC Extra Class Course, Four had passed the exam. The others were very close to passing. KC8WPW and NE8WR will be teaching a Technician Course starting Monday, January 26, 2009 at the Southfield EOC Offices. Cost: \$20. for the manual.

K8UP will teach a Technician Course starting Tuesday, February 3, 2009 at the Novi Police Training Center on Ten Mile Road. The class is primarily for CERT members, but anyone can attend.

K8UP will schedule a General Class course in April at the Southfield EOC.

K8ABZ compiled data from the HPARC Membership Roster and found that there were 18 Technicians, One Technician Plus, 31 Generals, 7 Advanced, and 68 Extra Class licensees. Members were urged to upgrade, if they were able.

### New Business

### Membership

## CONTEST CORNER

**Midway Atoll on the Air**

The US Fish and Wildlife Service ([USFWS](#)) announced on Monday, January 26 that they would once again [allow Amateur Radio operators the opportunity to operate](#) from [Midway Atoll](#). This the first time that USFWS has allowed amateurs to operate from the wildlife refuge since 2002. The USFWS started a program earlier this month to encourage visitors to experience Midway's wildlife, history and culture, as well as non-wildlife-dependent activities -- including Amateur Radio.

**ARRL Officially Okays CW Skimmer Contest Use**

After months of official review, the ARRL has decided to allow the use of the controversial CW Skimmer program only for multi-ops and single operators using assistance in ARRL contests, mirroring a decision made last year by the CQ WW DX Contest. The ARRL will also re-name the Assisted category as "Unlimited."

**LoTW Tip**

While checking out my confirmed QSO's I realized they did not quite match up. Then I was reading some mail lists and heard about "rules". People were emailing the league and having them fix their accounts. I believe I have figured out what has been the main problem. Make sure you have these rules in place:

1. DXCC includes ALL callsigns you ever had AND you combine them under your current callsign. For instance, I was KA8DMR and when I got my vanity callsign N8FE, I went online and combined my KA8DMR QSO's under N8FE.
2. WAS award: make sure you have at least ONE rule and that can be your callsign. However if you have logs with more than one callsign like I do then you need to make a rule for EACH callsign. Also I made a rule for QSO's to be after (and make sure you pick a date EARLIER than your earliest log entry. Make sure that the rules are "OR" rules not "and" rules.

FREE ARRL MEMBERSHIPS TO SERVICE MEN AND WOMEN ABROAD:

A few years ago, the Board approved a temporary rule to offer full ARRL membership free of charge to service men and women who hold FCC amateur licenses while they are serving outside the US. This temporary rule was made permanent. The rule reads as follows:

"Upon request, the Executive Vice President is authorized to maintain membership privileges without charge for the duration of a member's active military deployment outside the ARRL operating territory as described in Bylaw 30, with or without the delivery of QST at the member's option."

## RILEY REPLACED

---

Laura L. Smith of Pennsylvania has been named by the FCC to fill the vacancy created when by Riley Hollingsworth, K4ZDH retirement as the FCC Special Counsel for the Spectrum Enforcement Division. Riley held the position as FCC's enforcement guru for Amateur Radio for over 10 years. He is an excellent man, a fine ham and did a great job.

Ms. Smith began her legal career with the FCC in the Mass Media Bureau and Wireless Telecommunications Bureau. She also was Deputy Division Chief of the Public Safety and Private Wireless Division. She left the Commission in 1998 to join the Industrial Telecommunications Association (ITA), now the Enterprise Wireless Alliance.

Most recently, Smith was an attorney with the Maryland law firm of Shulman Rogers. While there, she dealt with telecommunications matters and served as counsel to numerous entities in the private radio and public safety communities. Smith has served as an industry consultant and written columns for a variety of trade publications including Mobile Radio Technology Magazine and The Private Wireless Magazine.

In an October 2008 letter to then-FCC Chairman Kevin Martin, ARRL President Joel Harrison, W5ZN, urged Martin to name a successor to Hollingsworth. President Harrison cautioned, "The appointment of a replacement Special Counsel in this position is of critical importance to the Amateur Radio Service, as the delay in finalizing the appointment stands to undermine in very short order an exceptionally successful and low-cost program of enforcement in the Amateur Service."

Although Ms. Smith apparently has had no direct involvement with Amateur Radio, her experience with other radio services should provide her with the basic background needed to fill the amateur enforcement post.

BOY SCOUTS OF AMERICA: The Board passed a resolution to offer ARRL assistance in managing station K2BSA at the 2010 National Scout Jamboree. It is set for July 26-August 4 to coincide with the 100th Anniversary of the Boy Scouts of America. We also are exploring the mutual desirability of a SOU between the Scouts and ARRL.

To date, **156** persons have signed-up for the PRB-1 eMail list. While this is gratifying, consider the following statistics:

- There are **over** 21,000 Amateur Radio Licensees in the State of Michigan
- There are 116 Amateur Radio Clubs in Michigan
- Of these 81 are ARRL Affiliated Clubs
- There are 4,248 Amateur Radio Licensees who are members of ARRL Affiliated Clubs
- Of these 2,823 are ARRL dues paying members

While I will acknowledge that some of the 21,000+ licensees are *not active*, we *definitely* need the support and action of **all** Amateur Operators to make this legislative effort successful. Please encourage your fellow HAMs to sign-up for the eMail list so we can keep them informed of our progress and let them know when the time comes to write to their elected representatives.

I have added what I believe is a *significant* page to the Committee Web Site entitled "[Benefits of PRB-1 Legislation](http://www.prb1michigan.org/id24.html)" [www.prb1michigan.org/id24.html](http://www.prb1michigan.org/id24.html). I believe that this page is an *excellent* one-page summary of what this initiative is all about and **why** legislators, their constituents, local municipalities, and zoning boards should support our proposed legislation. video by Walter Cronkite KB2GSD about [Amateur Radio Today](#), I encourage you to do so. This video highlights the significant contributions made by Amateur Operators during 911 and during the wildfires in the Western US during 2002. ## SWITCH TO 406

On February 1, 2009 the International Cospas-Sarsat Program terminated satellite processing of distress signals from 121.5 and 243 MHz emergency beacons. All mariners, aviators, and individuals using emergency beacons on those frequencies will need to switch to those operating on the newer, more reliable, digital 406 MHz frequency if they want to be detected by satellites.

Currently only 12-15% of the registered aircraft in the United States are flying with 406 MHz ELTs. This means that there is at least an 85% chance that an aircraft in an accident will only transmit a 121.5 MHz signal, thus remaining silent to the satellites. It will be up to other pilots monitoring the 121.5 MHz frequency in the cockpit to alert Search and Rescue authorities to accidents involving 121.5.

If a 121.5 MHz ELT is heard on guard, report to the nearest air traffic control tower, the time and location of when you first detect the ELT, when it is the loudest and when it drops off your radio.
