PRESIDENT'S QRM

Welcome back to all of the folks who have returned after the summer and made it to the September meeting. The presentation about the Hellschreiber machine was quite interesting. Mechanically converting text and graphics into pulses is an interesting idea. The description of the mechanism shows that a whole lot can be done without microprocessors or even much electronics. Things are different now.

For the first meeting we did not have any sound system at all, but we will have one for the next meeting since it is clear that not everybody could hear. It is important for all to be able to hear. It is sometimes a challenge to pay attention when you can't hear what is being said.

I don't have any DX contacts or any contests to announce, but I would like those who participate in these activities to tell us about them at our club meeting the next month, and possibly share a write-up in the Zero Beat with us as well.

We have an assistant swap chairman now, which is good because now is the time when the first swap activities must get started. A successful ham radio club swap does take a lot of advance effort. I am still looking for a net manager for the Sunday night net. The job is not hard, and does not require one to be net control every time. The net manager is supposed to have a team of operators to take turns being net control. If there are ten operators then each one only has to be net control five times a year. That is not a lot of work.

For those members who read QST, what about that article on a transistor 1KW amplifier for 2 meters? I was quite disappointed when there were no circuit drawings included, only references to some websites. The circuit drawings are educational for most readers, so what were the editors thinking?

One last item is about the repeater. For years we have been calling the DART "the friendliest repeater in town", and it seems to be just that. But it does take a bit of work to keep that reputation. We all need to put in a bit more effort to answer that call from the stranger that we hear, and make them feel welcome. A little bit of talk to a stranger is not expensive and doesn't take that much time. In addition, in order to hang onto frequencies we need to be using them. That is how we lost so much of the 220 band, and

VES MOBILE Still OK

Amateurs worried about Ontario's tough Driver Distraction law can breathe a little easier. Radio Amateurs of Canada (RAC), the national amateur radio association, announced a new five-year exemption for hams and twoway commercial operators running mobile stations.

Ontario Transportation Minister Bob Chiarelli confirmed the exemption, good to January 1, 2018. In his letter, Chiarelli hoped that hands-free alternatives would be in wide use by that date. RAC's strategy is to push for permanent exemptions like those already in place in other parts of Canada.

So those going to Windsor and beyond can operate mobile with no fear of getting a ticket.

South Sudan and Kosovo Licenses

Two new nations have started issuing amateur radio licenses.

In South Sudan, the telecommunications ministry has licensed James Z81A (K7QI) and Diva Z81D (YI1DZ). In addition, Z88Z has been licensed as a remote base station, to be operated by W7DXX from the USA. No word yet on when South Sudanese citizens will start to get their licenses.

In Kosovo, now recognized as independent by 92 countries but not by the United Nations, ham radio operation is just getting underway. Local amateurs, formerly with Serbian callsigns, are organizing to push for regular licensing. The first Kosovar station, Z60K, went on the air in September to demonstrate the hobby.

However, Kosovo has not yet been assigned a callsign block by the IARU, so Z6, currently unused, was taken unofficially. Contacts with Z6 stations do not count for DXCC at this time.

Kosovar amateur radio has unfortunately been caught up in world politics, with Russia and China against recognition of the country. So for now it will exist in a gray area.

Now FOUR ΟΝΤΑΓΙΟ SECTIONS

Radio Amateurs of Canada (RAC) has split the most populous Canadian province into four sections, effective September 1. The Ontario section is replaced by Ontario North, Ontario South, Ontario East and Greater Toronto Area (ONN, ONS, ONE and GTA, respectively). Windsor and southwest Ontario are part of Ontario South.

Ontario North, the largest, least populated new section, will likely be a "rare one."

The first activity using the change is the ARRL Sweepstakes, which will now require 83 multipliers to achieve a Clean Sweep. Other contests that use sections, such as Field Day, will also change. Some logging software already handles this change, while some vendors' software will not be updated until as late as January 2013.

SOLAR CYCLE PEAK EXPECTED MID-2013

This sunspot cycle, Cycle 24, has been probably the poorest in living memory. It's been so weak and slow to start that some people have even speculated sunspot cycles could disappear.

Expert predictions say otherwise. Sunspots won't disappear, but some cycles are better than others.

Older hams can remember stories about hams "loading up a light bulb" and getting calls from all over, or working the world on ten watts. These stories likely came from Cycle 19, which peaked around 1959 with smoothed sunspot numbers around 200. In contrast, Cycle 24 is expected to peak in the 70s. In August, Dr. David Hathaway, a solar physicist at the NASA Marshall Space Flight Center, gave his annual "solar cycle update" talk at the Huntsville Hamfest. While it wasn't all gloom and doom, Hathaway pointed out that the current Cycle 24 has one of the lowest levels of sunspot counts since record-keeping began more than two centuries ago.

Hathaway presented NASA's latest predictions, down slightly from last year's estimates. The graph below tells the story. His conclusions, verbatim from his slides:

- Cycle 24 will peak in mid-2013.
- Cycle 24 will be the smallest cycle in 100 years.

So next year should bring the best propagation for a while.

FCC ON PROPERTY COVENANTS: NO NEW RULES

In recent years, property covenants, homeowners association rules and other private restrictions on amateur antennas have made it much more difficult to put a station on the air in some parts of the country. Early this year, as mandated by Public Law 112-96, the FCC was required to study the uses and capabilities of amateur radio in emergencies and disaster relief. One key section included the goal of identifying "impediments to enhanced Amateur Radio Service communications," or in other words, these private, non-zoning property restrictions, known collectively as "CC&Rs."

In April, the FCC opened a proceeding that asked sixteen specific questions. The ARRL jumped in with both feet, filing a 128-page brief with dozens of examples of restrictive covenants. The League pointed out that "association-governed communities" were home to 62 million Americans, and in the last five years, 80 percent of new housing was organized this way. The League saw this as a significant problem for raising amateur antennas. ARRL claimed: "The result is that in the areas of the country with the fastest population growth it is virtually impossible to avoid restrictive covenants when purchasing a home."

The FCC's report in August didn't buy this argument. In 1985, the Commission's "PRB-1" order partly preempted local and state antenna regulations, ruling that they needed to be minimal and reasonably accommodate amateur radio antennas and support structures. The FCC did not include CC&Rs in the order because they were private and no one forced a person to buy property subject to CC&Rs. An August QST editorial hoped the FCC would reverse itself and apply PRB-1 types of preemption to private restrictions.

Instead, the FCC concluded: "[W]hile commenters suggest that private land use restrictions have become more common, our review of the record does not indicate that amateur operators are unable to find homes that are not subject to such restrictions." The Commission thus saw no reason to regulate private restrictions.

In other words, it's up to individual amateurs to find homes where they're allowed to put antennas up. The Federal government is not going to take sides.

In another part of the ruling, the FCC recommended that the Department of Homeland Security get more involved in developing standardized training for amateur emergency operations, and standardized policies for amateur access to disaster areas. It's too soon to tell whether DHS will do anything with this.
